- 1. For profit organizations must agree to pay a 5% royalty fee to the Jordan School District on all profit earned when using District marks/logos.
- 2. JPS marks/logos may not be used as an outside organization's primary logo identity.
- 3. No alteration or placement within an organization's identifiable markers of JPS marks and logos is allowed. If the approved use calls for change, requester must submit art.
- 4. JPS reserves the right to require samples of all content or materials for review and approval prior to use and/or placement of the logo and prior to placement. For expediency, please attach a jpeg or PDF of proposed artwork along with this authorization form.
- 5. Permission for use of marks and logos is granted only for one-time use and only for purposes listed in the statement of intended use. Please apply in writing for any additional use.
- 6. Permission does not include the right to rent or loan to other individuals or organizations.
- 7. Jordan Public Schools' marks/logos may not be used in the advertisement of alcohol or tobacco products.
- 8. The Jordan logo, taglines, trademarks, intellectual property and related concepts are the exclusive property of Jordan Public Schools. Adherence to these standards is required. Any information about the misuse or unauthorized use of the Jordan marks should be referred to the Jordan Communications Department. Violations will result in the revocation in the organization's use of District trademarked graphics for a period of two years.
